The Russ Hawkins yearly event is coming soon. The room #4 bathroom is currently being remodeled. Dave has secured a material price for the road work at \$17 per ton. One load is expected to do about a 100 yards depending on the condition of the road. Hill unit 3 will be the target area for road work this coming summer. Next year will be Hill Unit 2 and Hill Unit 1 will follow. All of the construction projects previously approved have been completed.
